EMERGENCY MEASURES 1



MAXIMUM VOLUME OF WATER PER INHABITANT PER DAY

Volumes delivered for population supply cannot exceed a maximum equivalent allocation of **138 liters per inhabitant per day**, including economic and commercial activities.



SWIMMING POOLS

The total or partial filling of all types of swimming pools is prohibited. Only partial refilling is allowed, using water in the quantities essential to guarantee sanitary quality and that have water recirculation systems, of:

- **Indoor swimming pools** registered in the list of sports facilities of the Generalitat de Catalunya, as long as they apply saving measures equivalent to the volume of water used in refilling (closing showers or others).
- **Outdoor pools** that are used all year round for federated sports. They are forced to close the showers to compensate for their use.

Filling and partial refilling of:

- **Seawater swimming pools** : their full or partial filling is allowed as long as they are filled and emptied without connection to the sanitation networks (since they can damage the operation of the sewage treatment plants)



IRRIGATION – Green areas and public and private gardens

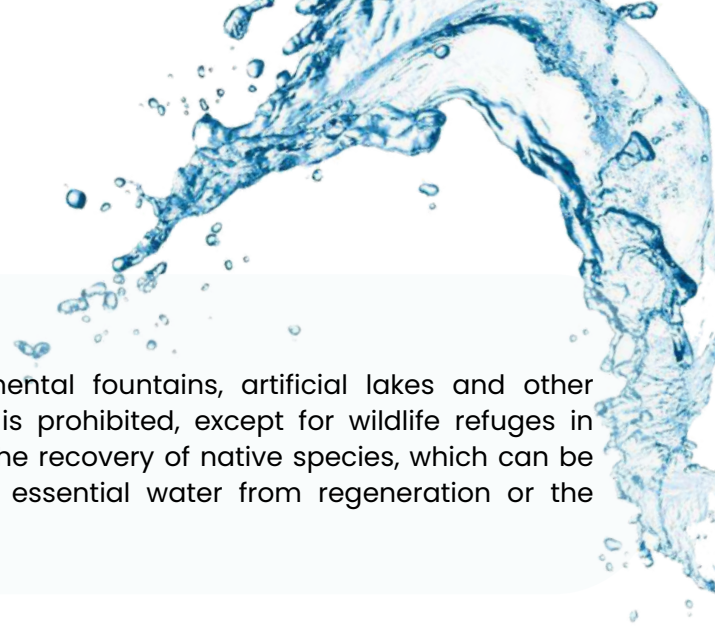
The use of water for the irrigation of gardens and green areas, both public and private, is prohibited, except:

- For the survival of trees and public botanical gardens if it is done with regenerated water or groundwater
- Watering must be done in hours of low insolation, using the minimum amount of essential water. The source of the non-potable water used must be visibly indicated.



SPORTS IRRIGATION

- The irrigation of grass sports fields (or other surfaces that require irrigation) for the practice of federated sport only, may be carried out with regenerated or phreatic water.
- Additional savings measures equivalent to the volume of water used in irrigation must be applied, including the closing of showers if necessary.
- Watering must be done in hours of low insolation, using the minimum amount of essential water. The source of the non-potable water used must be visibly indicated.



ORNAMENTAL SOURCES



The total or partial filling of ornamental fountains, artificial lakes and other elements of aesthetic use of water is prohibited, except for wildlife refuges in danger of extinction or intended for the recovery of native species, which can be filled with the minimum amount of essential water from regeneration or the groundwater.



CLEANING of vehicles

The cleaning of any type of vehicle is prohibited except that the cleaning is carried out in commercial vehicle cleaning establishments with water recirculation.

CLEANING of streets and urban furniture



- The cleaning with potable water of streets, sewers, pavements, facades and the like, whether public or private, is prohibited unless the cleaning is the result of an accident or a fire, or there is a health risk or a risk to the road safety. In these circumstances, cleaning will be done with the minimum amount of water necessary. Reclaimed water or ground water can be used.
- The cleaning of shop windows and windows with a bucket and sponge is allowed.



SHOWERS ON THE BEACHES

It is forbidden to use the showers and facilities for cleaning the feet on the beaches.



DUST IN THE AIR

The use of water for the removal of dust and suspended matter in the air is prohibited.
